Subject: Equity in Athletics Report

The *Equity in Athletics Disclosure Act (EADA)* was designed to make current and prospective students and the public aware of an institution of higher education's commitment to providing equitable athletic opportunities for its men and women students. Volleyball-Women: There is one female assistant coach who is assigned to the team on a part-time basis. She is a part-time CWC employee.

Rodeo-Women: There is one female assistant coach and one male assistant coach who are assigned to the team on a part-time basis. They are both part-time CWC employees.

Soccer-Women: There is one male assistant coach who is assigned to the team on a part-time basis. He is a part-time CWC employee.
